Please clarify and distinguish the Excel spreadsheets entitled DE 22-039 SCRC Attachment MBP-11.xlsx and DE 22-039 SCRC Attachment MBP-12.xlsx

**Response:**

There is no Excel version of Attachment MBP-12. Attachment MPB-12 provides proposed revisions to the Company's tariff. The Company inadvertently filed an Excel file named Attachment MBP-12 that was misnamed. This misnamed file was a second copy of Attachment MBP-11. On June 28, 2022, the Company advised the Clerk's Office at the Public Utilities Commission via electronic mail and telephone of this error and confirmed that the Excel file named Attachment MBP-12 should be deleted and disregarded.

For clarity, the Company is including the Excel version of Attachment MBP-11 that was included with the Company's initial filing together with this response. The Company is also providing Attachment RR-002-2 which is a revised version of Attachment MBP-11 to remove the impacts of the Company's Third Step Adjustment filed in Docket DE 22-030. The Commission issued a procedural order on July 7, 2022 in Docket DE 22-030 that delays the hearing in that proceeding; as a result, the rate effective date for the Company's Third Step Adjustment will also be delayed beyond August 1, 2022. At the July 14, 2022 technical session with Department of Energy the Company confirmed that it would prepare a revised bill impact to address this rate delay. Attachment RR-002-2 provides this update.
