GOVERNOR'S VETO MESSAGE ON HB 52

By the authority vested in me, pursuant to part II, Article 44 of the New Hampshire Constitution, on May 27, 2022, I have vetoed House Bill 52 and Senate Bill 200, apportioning congressional districts. The citizens of New Hampshire will not accept Senate Bill 200, which moves both members of Congress into the same district. Also, by moving Manchester into Congressional District 2 we would be creating a single district dominated by our largest urban areas. House Bill 52 is not in the best interest of New Hampshire. Granite Staters' expect districts that hold our incumbents accountable so that no one elected official is immune from challengers or constituent services. Appropriately apportioned congressional districts are vital to a representative government. For the reasons stated above, I have vetoed House Bill 52 and Senate Bill 200.

Floor Amendment to HB 2023-FN-A

Amend the title of the bill by replacing it with the following:

AN ACT making appropriations to the department of energy for a state emergency fuel assistance program and a supplemental electric benefit, relative to the electric low-income program fund, and relative to net energy metering limits for individual and business customers.

Amend the bill by deleting section 1 and renumbering the original sections 2-5 to read as 1-4, respectively. Amend the bill by replacing section 4 with the following:

4 Definition; Customer-generator. Amend RSA 362-A:1-a, II-b to read as follows:

II-b. "Eligible customer-generator" or "customer-generator" means an electric utility customer who owns, operates, or purchases power from an electrical generating facility either powered by renewable energy or which employs a heat led combined heat and power system, with a [total peak generating] nameplate or maximum rated capacity of [up to and including one megawatt,] less than 5 megawatts and that is located behind a retail meter on the customer's premises, is interconnected and operates in parallel with the electric grid, and is used to offset the customer's own electricity requirements in the first instance. Incremental generation added to an existing generation facility, that does not itself qualify for net metering, shall qualify if such incremental generation meets the qualifications of this paragraph and is metered separately from the nonqualifying facility.

- 5 Net Energy Metering; Net Effects. Amend RSA 362-A:9, VII to read as follows:
- VII.(a) A distribution utility may perform an annual calculation to determine the net effect this section had on its default service and distribution revenues and expenses in the prior calendar year. The method of performing the calculation and applying the results, as well as a reconciliation mechanism to collect or credit any such net effects with appropriate carrying charges and credits applied, shall be determined by the commission
- (b) For the purposes of accounting for any exports to the distribution grid by customer-generators, such exports shall be treated as reductions to the customer-generator's electricity supplier's wholesale load obligation for energy supply as a load serving entity, net of any applicable line loss adjustments as approved by the commission.
- (c) A generator that first becomes operational on or after July 1, 2019 shall only be eligible to participate in net metering as a customer-generator if it does not register as a generator with ISO England, is not considered a "Network Resource" or "Asset" by ISO New England, and does not participate in any other sale of electricity in interstate commerce.
- (d) A generator that first became operational before July 1, 2019 and that has outstanding capacity commitments in the forward capacity market administered by ISO New England, is registered as a generator with ISO New England, or is considered a "Network Resource" or "Asset" by ISO New England, may elect to become a customer-generator and participate in net metering upon retirement from all wholesale electric markets administered by ISO New England. A generator in the process of retiring from FERC regulated electric markets may prospectively register as a group host pursuant to paragraph XIV provided that net metering tariffs under this section shall not be effective until such retirement is effective.
- (e) Any provisions of settlement agreements or orders that have been approved or issued by the commission that relate to a distribution utility's treatment of the output from qualifying facilities or independent power producers shall not apply to the output from an eligible customer-generator participating in net metering.
 - 6 Net Energy Metering; Transition of Tariffs. Amend RSA 362-A:9, XV to read as follows:

- XV. Standard tariffs that are available to eligible customer-generators under this section shall terminate on December 31, 2040 and such customer-generators shall transition to tariffs that are in effect at that time. Alternative tariffs shall be applicable and have such grandfathering provisions as may be approved or adopted by the commission under this section. Customer-generators with a nameplate or maximum rated capacity of more than one megawatt and less than 5 megawatts that are eligible for net metering before the commission adopts tariffs specifically for customer-generators with a generating capacity of more than one megawatt shall:
- (a) Be eligible to receive the export credit rate approved by the commission in Order No. 26,029 (DE 16-576) for one megawatt sized customer-generators on default service, namely, the applicable default energy service rate.
- (b) Be grandfathered by the terms of currently applicable tariffs for customer-generators with a total peak generating capacity of one megawatt if the customer-generator's electrical generating facility first becomes operational on or after July 1, 2019.
- (c) Transition to such new tariffs as are specifically approved by the commission for customer-generators with a nameplate or maximum rated capacity of more than one megawatt if the customer-generator's electrical generating facility first became operational before July 1, 2019.
- 7 New Subparagraph; Restructuring Policy Principles; System Benefits Charge. Amend RSA 374-F:3, VI-a by inserting after subparagraph (d) the following new subparagraph:
- (e) To the portion of energy efficiency funds reserved for low-income energy efficiency programs as approved by the commission via Order No. 26,621 dated April 29, 2022, there shall be added the sum of \$10 million for the Home Energy Assistance program approved at page 30 of Order No. 26,621. Such sum is hereby appropriated to the department of energy for the fiscal year ending June 30, 2023. The governor is authorized to draw his warrant for such sum out of any money in the treasury not otherwise appropriated. These additional funds shall provide additional support of home weatherization for income-eligible customers. Notwithstanding any commission order to the contrary, the maximum amount to be expended on any individual project by the Home Energy Assistance program shall be \$20,000 unless that amount is increased by the commission. Any funds authorized by this subparagraph, if unspent during the current planning cycle, shall not lapse and shall carry forward to subsequent planning cycles.
 - 8 Effective Date. This act shall take effect upon its passage.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 346:1 Legislative Findings and Purpose. The general court finds that:
- I. Heating costs in the state of New Hampshire are predicted to rise to unprecedented and potentially catastrophic levels during the 2022-2023 winter season and electric costs have approximately doubled for many Granite Staters.
- II. In addition to these fuel and electric costs, Granite Staters are also facing price inflation on everyday items and high gasoline prices, which affect household budgets. There are programs in New Hampshire delivering monetary aid to households having up to 60 percent of the median income in New Hampshire, and it is reasonable to assume that inflation will extend the potential need for aid to households with income above that limit.
- III. Price inflation is largely driven by federal policies, federal spending, the Federal Reserve, and worldwide events over which we have no control. Inflation reduces spending power. Due to reduced spending power, households with New Hampshire residents who earn between 60 percent and 75 percent of the state median income may also need relief.
- IV. The fiscally responsible leadership of the 2021-2022 general court has created a favorable economic environment that has helped businesses outperform initial estimates thereby creating a budget surplus. This budget surplus can be used to supplement electric and home heating expenses for households within the 60 percent to 75 percent median income bracket without raising the future tax burden of the state.
- V. It is prudent to enact a one-time relief package for these extraordinary circumstances and not a permanent program. Relief payments will not be paid to applicants, but rather directly to their utility companies.
- VI. Providing direct aid via these surplus funds may reduce the burden on local municipalities' welfare programs thereby offsetting a potential increased tax burden that would otherwise be passed along to property owners at the local level.
- 346:2 Department of Energy; State Emergency Fuel Assistance Program; Supplemental Electric Assistance Program; Appropriation; Report.
- I.(a) The department of energy, division of policy and programs, shall administer a state emergency fuel assistance program for the fiscal year ending June 30, 2023. To the extent of funds specifically appropriated for the program, the program shall provide assistance in the amount of \$450. To be eligible, a household shall have an annual income greater than 60 percent of the state median income to at or below 75 percent of the state median income. The program shall provide assistance with regard

to the same fuels and shall be administered in the same manner as LIHEAP is managed in New Hampshire on the effective date of this act. Applications for this program shall be accepted through April 30, 2023.

- (b) The sum of \$25,000,000 for the fiscal year ending June 30, 2023 is hereby appropriated to the department of energy for the purpose of implementing the state emergency fuel assistance program under subparagraph (a), including administrative and advertising costs related to this program. These funds shall be accounted for separately from federal LIHEAP funds and other funds held by the department of energy. The governor is authorized to draw a warrant for said sum out of any money in the treasury not otherwise appropriated. Any unexpended funds remaining on June 30, 2023 shall be lapsed to the general fund.
- II.(a) The department of energy, division of policy and programs, shall administer a program to provide a supplemental electric benefit for the fiscal year ending June 30, 2023. To the extent of funds specifically appropriated for the program, the program shall provide a household single credit in the amount of \$200. To be eligible, a household shall have an annual income greater than 60 percent of the state median income to at or below 75 percent of the state median income and have an electric account in their name with any electric distribution utility providing service in the state, including municipal electric distribution utilities. Applications for this program shall be taken in conjunction with the emergency fuel assistance program.
- (b) There is hereby appropriated the sum of \$ 10,000,000 for fiscal year ending June 30, 2023, to the commissioner of the department of energy for the purpose of administering a supplemental electric benefit for the fiscal year ending June 30, 2023, including administrative and advertising costs related to this program. These funds shall be accounted for separately from all other funds held by the department of energy. The governor is authorized to draw a warrant for said sum out of any money in the treasury not otherwise appropriated. Any sum not expended by the department of energy by June 30, 2023, shall lapse to the general fund.
- III. The administration of the state emergency fuel assistance program in paragraph I and the supplemental electric benefit in paragraph II by the department of energy shall be exempt from the provisions of RSA 541-A.
- IV. On or before 60 days after the close of the fiscal year ending June 30, 2023, the department shall report to the fiscal committee of the general court and governor and executive council, the amount of moneys paid under this act for the fiscal year ending June 30, 2023.
 - 346:3 Electric Low-Income Program Fund. Amend RSA 374-F:4, VIII(c) to read as follows:
- (c) The portion of the system benefits charge due to programs for low-income customers shall not exceed 1.5 mills per kilowatt hour. If the commission determines that the low-income program fund has accumulated an excess of \$1,000,000 and that the excess is not likely to be substantially reduced over the next 12 months, it shall suspend collection of some or all of this portion of the system benefits charge for a period of time it deems reasonable. *The commission shall take no action to determine the accumulation of any excess in the low-income program fund or otherwise suspend the*

collection of some or all of the system benefits charge related to the low-income program fund before June 30, 2024.

346:4 Appropriation; Electric Low-Income Program Fund. There is hereby appropriated the sum of \$7,000,000 to the department of energy, which shall be continually appropriated to the department and shall be nonlapsing, to supplement the dedicated fund described in RSA 6:12, I(b)(71), which, like other moneys in that fund, shall be maintained pursuant to the provisions of RSA 6:12-b and managed in accordance with the electric assistance program benefit levels and procedures established by the public utilities commission. The governor is authorized to draw a warrant for said sum out of any money in the treasury not otherwise appropriated.

346:5 Effective Date. This act shall take effect upon its passage.
