Procedural Order Re: Proposed Procedural Schedule

On September 29, 2022, the Commission granted the request of Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) to sever the following two issues from the remainder of this docket for adjudication on a separate procedural schedule: (1) a Revenue Decoupling Adjustment Factor (RDAF) under-collection issue; and (2) gas holder costs. *See* Order No. 26,692 (September 29, 2022). In that order, the Commission required the parties to develop and file a new procedural schedule to address these two issues. *Id.*

On November 4, 2022, the New Hampshire Department of Energy (DOE), with the assent of the Office of the Consumer Advocate (OCA) and Liberty, filed the following proposed procedural schedule for the Commission's approval:
