Procedural Order Re: Request to Modify Procedural Schedule

On November 17, 2022, the Commission issued a procedural order approving a procedural schedule governing two issues in this matter that were severed from the underlying annual Cost of Gas and Local Distribution Adjustment Charge proceeding: (1) a Revenue Decoupling Adjustment Factor (RDAF) under-collection issue; and (2) recovery of gas holder costs.

On December 8, 2022, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) filed a supplemental petition pursuant to the approved procedural schedule. In its supplemental petition, Liberty requested two modifications to the approved procedural schedule to accommodate the filing of supplemental testimony related to the gas holder costs, specifically: the insertion of a deadline for filing the testimony of Liberty's engineers pertaining to estimated demolition and related remediation costs; and the extension of the December 19, 2022 discovery deadline. Liberty's requested modifications to the approved procedural schedule are represented in **bold** and strikethrough as follows:
