**AFFIDAVIT OF PUBLICATION**

NOW COMES Susan S. Geiger, upon oath, being duly sworn, and states as follows:

1. I represent Charter Communications, Inc. (“Charter”), Cogeco US Finance, LLC d/b/a Breezeline (“Breezeline”), and Comcast Cable Communications, LLC (“Comcast”) (collectively, “the Petitioners”) in the above-captioned docket.

2. On September 28, 2022, the New Hampshire Public Utilities Commission (“the Commission”), issued an order entitled “Commencement of Adjudicative Proceeding and Notice of Prehearing Conference” (“the Order”) in the above captioned docket. Among other things, the Order directed the Petitioners to publish a copy of the Order on their websites no later than two business days after the date of the Order, and to document such publication by affidavit filed with the Commission on or before October 11, 2022.

3. On September 29, 2022, the Order was published on Breezeline’s website at <https://www.breezeline.com/policies-agreements> under the title “Notice of NH Public Utilities Commission Proceeding”.

4. On September 29, 2022, the Order was published on Comcast’s website at <https://www.xfinity.com/policies> under the title “Notice of NH Public Utilities Commission Proceeding”.

5. Due to an emergency, Charter was not able to upload the Order to its website by the two business day deadline set forth in the Order. On September 30, 2022, Charter filed a motion to extend the publication deadline by an additional business day, *i.e.*, until October 3, 2022, and the motion was granted by an order dated September 30, 2022.


