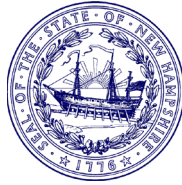

Dear Attorney Sheehan:

On January 31, 2023, the Commission issued a procedural order directing Liberty-Keene to refile final versions of all pending tariff pages in this docket to replace all previous filings of the pending tariff pages. On February 7, 2023, Liberty-Keene submitted the above-referenced tariff pages pursuant to that procedural order.

Employees of the New Hampshire Public Utilities Commission have reviewed the tariff filings received on February 7, 2023 in this proceeding. It has been confirmed that these rates are temporary, interim, and provisional until such time as the issue of the applicability and interpretation of Liberty's NHPUC No. 11 tariff is resolved. *See* Order No. 26,541 (October 29, 2021) and Order No. 26,542 (October 29, 2021). At such time that the tariff issue is resolved, the Commission will conduct a review and confirm the permanent rates in effect.

A copy of this letter is being entered into the docket and the tariff filing will be placed in our permanent file. In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time. A date stamped copy of the filed tariff pages is enclosed for your files.
