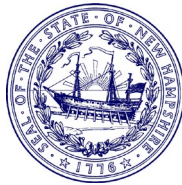

Re: DW 22-058 Bedford Waste Services Corporation Request for Change in Rates – Step 2 Proposed Procedural Schedule

Dear Chairman Goldner:

On September 12, 2023, the Public Utilities Commission (Commission) issued Order No. 26,884 (Order) approving the annual revenue increase and resulting rates included in the Settlement Agreement (Settlement) regarding permanent rates submitted by Bedford Waste Services Corporation (Company) and supported by the Department of Energy (DOE), in the above referenced docket.

The Order also included a Step 2 Adjustment, for the planned replacement of three additional pumps in 2023. The order directed the Company to file a petition for the proposed Step 2 Adjustment, no sooner than January 1, 2024, to be reviewed in a separate proceeding with the participation of the DOE.

On January 8, 2024, the Company filed its *Step 2 Compliance Filing* in the above referenced docket. After conferring, the Company and the DOE respectfully request that the Commission open a new proceeding for review of the Step 2 Adjustment and approve the below proposed procedural schedule for that review.
