Dear Chairman Goldner:

Pursuant to the Hearing Guidelines issued on September 20, 2022, in the above-captioned matter, the Department of Energy ("Department") submits this request on behalf of Alex Hill and Anirudh Kshemendranath from Dunsky Energy + Climate Advisors ("Dunsky") for permission for Dunsky to appear remotely at the March 12, 2024, Hearing scheduled in this matter.

Mr. Hill and Mr. Kshemendranath are both located in Canada, and requiring them to travel to New Hampshire for the hearing would be unduly burdensome. The Department therefore requests on their behalf that they be allowed to appear remotely.

The Department notes that Mr. Hill and Mr. Kshemendranath are not the Department's witnesses, and their testimony should not be considered to represent the Department's position in this proceeding. Rather, the Department makes this request on behalf of Dunsky as part of its role in administering the VDER study contract that stemmed from Commission Order No. 26,316, in order to make the authors of the VDER study available for questioning about the VDER study by the Commission and by parties to this proceeding, pursuant to Puc 203.24.

Consistent with the Commission's current practices, this letter is being filed only in electronic form.
