Petition for Approval of a Regulatory Asset and Waiver of Puc 2203.02(b)(5)

Procedural Order Re: Proposed Procedural Schedule

On February 17, 2023, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), with the assent of the New Hampshire Department of Energy, the Office of the Consumer Advocate, and the Community Power Coalition of New Hampshire, filed proposals for the resolution of the two matters in this docket.


First, Eversource represented that the parties anticipated resolving Eversource's petition for a waiver from New Hampshire Code of Administrative Rules, Puc 2203.02(b)(5) through a stipulation and affidavit that they intend to file with the Commission shortly. The Commission finds this proposed course of action reasonable and in the public interest, and therefore approves it. If the parties do not file the anticipated stipulation by March 31, 2023, Eversource shall file a status update with the Commission.

Second, with respect to Eversource's petition for a regulatory asset, the following schedule was proposed:
