


The undersigned hereby states under penalties of perjury as follows:

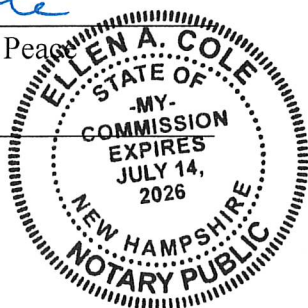
