On January 13, 2023, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty ("Liberty" or the "Company") submitted clean and redlined compliance tariff pages in accordance with the New Hampshire Public Utilities Commission (the "Commission") Order No. 26,745 (Dec. 14, 2022) in Docket No. DE 22-081 (Order No. 26,745 *Nisi* Approving Requests to Modify Energy Efficiency Portion of System Benefits Charges and Local Distribution Adjustment Charges).

On January 31, 2023, the Commission issued *Procedural Order Re: Compliance Tariff Filings* in Docket Nos. DG 22-045 and DG 22-057, directing Liberty to resubmit, in both dockets, the Base COG Rates, the December Adjustment, and the January Adjustment filings with the final versions of each revised page for which Liberty seeks Commission approval.
