**Re: DE 23-030 Request to remove condition on approval of Waterville Valley Community Power Plan**

Dear Chairman Goldner,

The Town of Waterville Valley's Community Power Plan was conditionally approved in Order No. 26,821 subject to the following single condition (emphasis added):

*"As such, we condition approval of Waterville Valley's Plan on its Education and Outreach Plan clearly communicating that **participants' exit from the program will be subject to reasonable notice to the distribution utility and may only occur after the next meter read, consistent with Puc 2204.05(g).**"*

To remedy this condition, we have added the highlighted language verbatim to the first paragraph in Exhibit II, and in the list of items to be included in the opt-out letter for eligible customers, see attached update with changes indicated. The Town of Waterville Valley takes customer notification very seriously, and appreciates the opportunity to clarify this issue further for its residents and businesses.

*The Town of Waterville Valley prohibits discrimination on the basis of race, color, national origin, sex, sexual orientation, religion, age, disability, or family status.*

*The Town of Waterville Valley is an equal opportunity employer.*

This notification is being sent at the same time to the department of energy, office of the consumer advocate, Eversource, the distribution utility with limited service in Waterville Valley, and the New Hampshire Electric Coop that serves most customers, as required under Puc 2204.01(g).
