On behalf of the Town of Tamworth attached please find the Tamworth Community Power Electric Aggregation Plan for review and approval by the Commission pursuant to RSA 53-E:7, II and Puc 2204.01.

This final plan was approved by PUC Order No. 26,947 on 2/13/24 and by voters at the Tamworth Town Meeting on 3/13/24. NH Electric Cooperative, one of the electric distribution utilities serving customers in Tamworth, was inadvertently omitted from the previous 2204.01 filing issued on 01/10/24. This notice comes as a correction to that oversight to ensure NH Electric Cooperative receives notice of the Tamworth Electric Aggregation Plan.
