Dear Chairman Goldner:

On May 5, 2024, the New Hampshire Public Utilities Commission (PUC or Commission) ordered the commencement of adjudicative proceeding and notice of hearing in this docket. As part of this order, the Commission scheduled a hearing date in this docket for June 26, 2024 at 1:00 pm. The Commission also required the DOE to file its position statement¹ on or before June 19, 2024 and ordered any party to file a request to intervene on or before June 10, 2024 and any party objecting to a petition to intervene by June 20, 2024. One of the DOE witnesses is unavailable June 26, 2024, and therefore the DOE is respectfully requesting that the PUC modify its earlier order. Accordingly, the DOE is requesting that the PUC approve the following revised procedural schedule which is supported by Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource") and the Office of the Consumer Advocate ("OCA").
