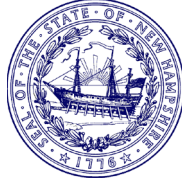

Energy 2024 Energy Service Solicitations – DOE Position

Dear Chairman Goldner:

On March 19, 2024, Eversource filed a proposed procurement timeline stating Eversource would submit its Energy Service Filing to the Commission on **June 13, 2024**. On May 6, 2024, in Docket No. DE 24-046, the Commission issued its *Commencement of Adjudicative Proceeding and Notice of Hearing* stating that the Department of Energy “shall file its position regarding Eversource’s petition, including the reasons for this position, on or before **May 31, 2024;**” (emphasis added). The Commission scheduled the hearing in DE 24-046 for **June 18, 2024**.

Given the abbreviated timeline between the default service filing and hearing, the Department of Energy submits this letter to respectfully notify the Commission that it intends to provide its position at the June 18 hearing, after it has an opportunity to review Eversource’s default service petition and resulting rates.
