Dear Chairman Goldner:

On May 1, 2024, Liberty Utilities (Granite State Electric) Corp. plans to issue a Default Service Request for Proposals ("RFP") to procure default service for the six-month period August 1, 2024, to January 31, 2025, for both the Large Customer Group ("LCG") and the Small Customer Group ("SCG").

Pursuant to the terms of the settlement agreement and orders approving Liberty's default service procedures,<sup>1</sup> Liberty plans to solicit a bid price that includes the cost of all market products on an as-delivered energy basis, including an all-inclusive bid price for LCG and 80% of the SCG. Additionally, pursuant to Order No. 26,984 (March 29, 2024) Liberty will be self-supplying from the ISO-NE market the remaining 20% of the SCG.

I am submitting, for notice purposes, the following proposed timeline for this RFP, and respectfully request a hearing on or about June 26, 2024, to meet the timeline:
