**Procedural Order Re: Rescheduled Hearing**


By supplemental order of notice dated August 7, 2024, the Commission scheduled a hearing in the above-captioned matter on October 1, 2024. Due to scheduling conflicts, the Commission **cancels the October 1, 2024** hearing and reschedules this matter to **October 23, 2024 at 9:00 a.m.** Three hours shall be allotted for this hearing. We assign Attorney Sarah Fuller, a Senior Advisor to the Commission, to serve as an examiner for the hearing, to report the facts, and draft a recommended final order. Any party to DE 23-002 may request that this hearing be held “by the full commission, or a majority thereof” so long as that request is made 5 days before the date of the hearing. *See RSA 363:17.*

The hearing shall be conducted in person, in accordance with the previously issued hearing guidelines. Pursuant to RSA 541-A:31, VII a verbatim sound recording will be made at the rescheduled hearing. Furthermore, pursuant to Puc 203.31, the Commission notifies the parties that **it will not** order a transcript of this sound recording. The hearing audio will be made available to the parties upon request.

As previously determined in a procedural order issued September 3, 2024, Unitil witness S. Elena Demeris shall be allowed to participate remotely. The filing of a separate request will be required for any other parties wishing to appear remotely.
