**Procedural Order Re: Pending Motions**


On March 22, 2024, Public Service Company of New Hampshire d/b/a Eversource Energy, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty, and Unitil Energy Systems, Inc. filed a joint motion requesting the Commission to schedule a prehearing conference and to issue a supplemental order of notice. Community Power Coalition of New Hampshire and Conservation Law Foundation filed a joint motion on March 28, 2024, which also requested the issuance of a supplemental order of notice and the scheduling of a prehearing conference. Responses to these motions were filed by the Office of the Consumer Advocate and the New Hampshire Department of Energy. Although there appears to be a consensus that a supplemental order of notice should issue, the parties have not agreed on whether the scope of this docket should be changed and, if so, what additional issues should be included in a supplemental order of notice.

Therefore, the Commission has scheduled another prehearing conference on May 2, 2024, at 9:00 a.m. to address the scope of this proceeding. See N.H. Admin. R., Puc 203.15(a). Three hours are allotted for this prehearing conference, which shall be conducted in accordance with the previously issued hearing guidelines. The parties' procedural schedule is SUSPENDED pending further order of the Commission, and the hearing scheduled on April 23, 2024 is CANCELLED.


