**Procedural Order Re: Cancellation of June 11 and June 12, 2024 Hearings;
Scheduling of Status Conference on June 4, 2024**

In light of recent developments in this proceeding, the Commission hereby CANCELS the hearings currently scheduled for this instant docket on June 11 and June 12, 2024, and hereby SCHEDULES a Status Conference for June 4, 2024 at 9:00 a.m. Three hours are allotted for this proceeding. Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) and the New Hampshire Department of Energy (DOE), together with other interested Parties to this proceeding, should be prepared to update the Commission on matters arising from Liberty's unilaterally-proposed Scope for the PricewaterhouseCoopers Report filed by Liberty on April 17, 2024. Following this Status Conference, the Commission may extend the previously-approved stay in this proceeding beyond June 7, 2024, pursuant to RSA 365:28, RSA 541-A:31, and allied authority, and/or disposition any DOE request for relief regarding next steps, or take other appropriate action.
