<u>Procedural Order Re: Scheduling of Commission-Attended Technical Conference on October 28, 2024 at 1:00 p.m.</u>

Reference is made to the filing by Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource or the Company) made on October 23, 2024, in purported response to the Commission directives related to the 'Chapter 340 Adder,' made in Order Nos. 27,053 (August 30, 2024) and 27,066 (October 16, 2024), which included a Technical Statement of Company personnel Ashley Botelho, Bryant Robinson, and Scott Anderson (Technical Statement), also dated October 23, 2024.

Within Order No. 27,066, the Commission ruled, "...Eversource is to implement the direct Orders of the Commission (Order Nos. 27,053 and this instant Order [No. 27,066]) for actual effect, through its Tariff, as of November 1, 2024. The Commission further reserves the right to schedule further proceedings in advance of October 31, 2024, if necessary to enforce the Company's compliance." *Id.* at 6-7. Having engaged in an initial review of the Company's October 23 filing, including the Technical Statement and the cover letter of counsel to the Company appended thereto, the Commission hereby SCHEDULES a Commission-attended technical conference in these consolidated proceedings on October 28, 2024 at 1:00 p.m. regarding the Company's October 23 filing.

Three hours are allotted for this technical conference. Eversource is also hereby ORDERED, to make available for Commission questioning, the personnel that prepared the Technical Statement, namely, Ms. Botelho and Messrs. Robinson and Anderson, at this October 28 technical conference. This Commission-attended technical conference shall be conducted in person, at the Commission's offices (Hearing Room 'A'), and shall be open to the public and to the parties to these proceedings.
