
**Joint Petition to Approve Transfer of Control**


**Procedural Order Re: Motion to Alter Procedural Schedule**

On July 10, 2024, Consolidated Communications Holdings, Inc. and Condor Holdings LLC (together, the Joint Petitioners) filed a motion to alter the procedural schedule that the Commission approved in its procedural order issued on March 22, 2024. The Joint Petitioners requested that the parties no longer be required to file briefs, but instead be allowed to make closing statements following the close of evidence at the hearing. They represented that the remaining parties in this docket either assented to their motion or had no objection to it.

The Commission GRANTS the Joint Petitioners' motion, so that the briefing requirement is eliminated. The parties shall be permitted to make closing statements after the close of evidence.
