#### Show Cause Proceeding<sup>1</sup>

### **Procedural Order Re: Post-Hearing Briefing**

On August 27, 2024, the Commission held a prehearing conference in this matter pursuant to New Hampshire Code of Administrative Rules, Puc 203.15, which was attended by Liberty Utilities (Granite State Electric) (Liberty or the Company), the Department of Energy (DOE) and the Office of the Consumer Advocate (OCA).

At the commencement of the prehearing conference the parties presented preliminary positions. The parties agreed with the Commission's proposal to convert the proceeding to a show case docket verses an investigatory docket. The parties also agreed that the preliminary legal issue to be resolved is as follows:

 Whether the Company is in contempt of the terms of the settlement agreement as contained in docket DE 19-064, Order No. 26, 376 (June 30, 2020), by allegedly failing to fulfil its requirements for vegetation management as contained in the settlement.

The parties requested eight weeks to provide initial legal briefs on the above question.

The Commission agrees to the 8-week deadline to file initial briefing on the above question. The Commission requests the parties also answer the following question in their initial brief:

• If the Company is found to be in contempt, what is the appropriate remedy?

The parties shall file their initial briefs on the above legal questions by October 22, 2024. Although not discussed at the August 27, 2024 hearing, the parties may file a reply brief by November 5, 2024.
