Dear Mr. McDermott:

On April 6, 2020, TFS Energy Solutions, LLC d/b/a Tradition Energy (Tradition Energy) submitted an application with the Commission to renew its registration as a provider of natural gas aggregation service.

Commission Staff filed a memorandum on April 14, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 3000. Staff recommended that Tradition Energy's registration application be approved for a five-year term, beginning on July 8, 2020.

The Commission has approved Staff's recommendation. Accordingly, Tradition Energy's application for registration is approved, effective as of July 8, 2020. The renewed registration is for a term of five years and expires at the close of business on July 8, 2025. Pursuant to Puc 3003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before May 9, 2025.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
