Dear Ms. Stokes:

On June 30, 2020, Goldstar Energy Group, Inc. (Goldstar) filed an application with the Commission to renew its registration as a provider of natural gas aggregation service. On July 6, 2020, Goldstar filed additional information listing the competitive natural gas suppliers to which it intends to provide service and a statement that the applicant is not representing any supplier interest.

Commission Staff (Staff) filed a memorandum on July 6, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Goldstar's registration application be approved for a two-year term, beginning on July 24, 2020.

The Commission has approved Staff's recommendation. Accordingly, Goldstar's application for registration is approved, effective as of July 24, 2020. The renewed registration is for a term of two years and expires at the close of business on July 24, 2022. Pursuant to Puc 3003.06(a), Goldstar must submit its next renewal application at least 60 days prior to the expiration of the approved registration term, on or before May 25, 2022.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. Those rules are available at: <u>http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf</u>.
