To the Parties:

On September 10, 2020, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) filed a motion to extend the deadline for its response to Intervenor Terry Clark's Amended Motion to Condition Keene Project on RSA 378 Consistency and Compliance and to Order Supplemental RSA 378 Filing (Amended Motion to Condition), which was submitted on August 31, 2020. Liberty requested the Commission to extend the deadline to September 17, 2020. *See* N.H. Admin. R., Puc 203.07(e) (establishing 10-day deadline for objections to motions other than motions for rehearing). According to Liberty, the active parties in this docket, including Mr. Clark, assented to its extension request.

Liberty stated that it requires additional time to obtain input from a number of its employees before it can adequately prepare its responses to the issues raised in the Amended Motion to Condition. It asserted that the proposed extension will not unduly delay the proceeding in the above-captioned matter.

Accordingly, the Commission has granted Liberty's request for an extension of the deadline for its response to the Amended Motion to Condition. *See* N.H. Admin. R., Puc 202.04. Liberty shall file its response to the motion on or before Thursday, September 17, 2020.
