Renewable Energy Fund Program Budget Adjustments

To Whom It May Concern:

On May 30, 2019, Staff filed a memorandum requesting approval to amend certain Renewable Energy Fund (REF) program budgets based on current program demand and projected spending for the remainder of fiscal year 2019 (FY19). The recommended reallocation of funds will have an insignificant impact on the balance of funds allocated between the residential and non-residential program sectors (*see* RSA 362-F:10) and will meet other statutory allocation requirements. Specific program adjustments are as follows:
