**Re: DE 10-024 and DE 10-212, Commercial and Industrial Solar Rebate Program  
Establishment of Program Waitlist and Program Closure**

To Interested Persons:

On August 29, 2018, the Commission approved the Renewable Energy Fund (REF) program budgets. On July 3, 2019, Staff informed the Commission through a Staff Memorandum that the REF Commercial & Industrial Solar Rebate Program (Program) has received applications for funding in excess of available FY19 allocated Program funds. Staff recommended establishing a Program waitlist, and closing the Program to new applications as of a specified date.

The Commission has authorized the creation of a waitlist for Program Step 1 applications received on and after July 1, 2019.

The Commission has further approved closing the Program to new applications that are received after July 3, 2019. The Program will remain closed until a further order is issued if and when additional funding becomes available during fiscal year 2020.
