On May 22, 2019, National Grid filed the following agreements pursuant to RSA 366:3:

National Grid USA Service Company, Inc. - Service Agreement
National Grid Engineering & Survey Inc. - Service Agreement

(the Agreements). Each Agreement is signed by the titular corporate entity listed above, as well as a number of affiliate entities. The Agreements replace prior affiliate service agreements addressed in Docket Nos. DA 10-006, DA 11-003, and DA 12-006.


Based on the current filing, the purpose of these Agreements is to provide common service agreements to National Grid affiliates. The services provided under these Agreements are substantially the same as the services provided under similar filings in Docket Nos. DA 10-006, DA 11-003, and DA 12-006.

This letter serves as an acknowledgment that National Grid, pursuant to the requirements of RSA 366:3, has filed modifications to certain affiliate services agreements between public utilities and their affiliate companies for the provision of services in exchange for compensation that exceeds \$500. This acknowledgment does not constitute approval of any rate or revenue requirement change that may be claimed as a result of the Agreements, as any rate issues may be addressed, as applicable, in another docket or through the opening of a new docket. The Commission will not open an investigation at this time under RSA 366:5.
