Re: DE 19-057, Public Service Company of New Hampshire d/b/a Eversource Energy
Notice of Intent to File Rate Schedules
Proposed 3-Month Extension of Procedural Schedule

To the Parties:

On March 26, 2020, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a letter, in which it confirmed its agreement to extend the procedural schedule in this proceeding for three months, according to the terms outlined in Commission Staff's (Staff) March 24, 2020 letter. Pursuant to the agreement, Eversource would waive whatever rights it may have under the suspension provisions of RSA 378:6, I(a) and continue to collect the temporary rates approved in Order No. 26,265 (June 27, 2019), subject to special provisions for collections related to vegetation management and the Tax Costs and Jobs Act of 2017. Eversource would be permitted to reconcile permanent rates to the temporary rates on a retroactive basis to July 1, 2019, once permanent rates are set. In its letter, Staff represented that the Office of the Consumer Advocate (the OCA) agreed with this approach to resolving the docket given the public guidance on the COVID-19 virus.

The Commission has determined to treat these submissions as a joint motion. Parties shall have 10 days from today's date, or until Thursday, April 9, 2020, to file an objection to this motion. N.H. Admin. R., Puc 203.07(e).
