On January 28, 2020, Sunwave USA Holdings, Inc. (Sunwave) filed a request to amend its competitive electric power supplier (CEPS) registration to serve residential and small commercial customers, as well as large commercial and industrial customers, in the service areas of Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) and Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty).

Commission Staff (Staff) filed a memorandum on June 4, 2020 summarizing Sunwave's filing and Staff's review of the proposed customer contract forms submitted with that filing. Staff indicated that it had asked Sunwave to make certain revisions to the contract forms and that Sunwave had made those revisions. Staff indicated that Sunwave's CEPS registration amendment request meets the applicable requirements of Puc 2003, Puc 2004, and Puc 2006.01, and Staff recommended that its registration be amended to permit service to residential and small commercial customers, as well as large commercial and industrial customers, in the Eversource and Liberty service areas.

The Commission has reviewed and approved Staff's recommendation. Accordingly, Sunwave's CEPS registration is amended to permit it to serve residential and small commercial customers, as well as large commercial and industrial customers, in the service areas of Eversource and Liberty.
