Revised Procedural Schedule

To the Parties:

On June 24, 2020, following a technical session held on June 17, 2020, Commission Staff (Staff) filed a status report and an updated procedural schedule, as required by the secretarial letter dated June 3, 2020. The proposed procedural schedule provides for an August 4, 2020 hearing date because, according to Staff, it is necessary for the Commission to issue a final order by the end of August for modifications to be in place by November 1, 2020, in the event that proposed modifications are approved and adopted. Staff stated that all parties agreed to the August 4 hearing date.

Staff, on behalf of Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty, Northern Utilities, Inc., and the New Hampshire Community Action Agencies, indicated that the parties are optimistic that a joint proposal will be filed, and requested the Commission to approve the following schedule. By way of a June 26, 2020 supplemental filing, Staff indicated that New Hampshire Legal Assistance, The Way Home, and the Office of the Consumer Advocate are also optimistic that a joint proposal will be filed and request the Commission to approve the following schedule.
