Dear Mr. Newman:

On July 13, 2020, Commission Staff (Staff) filed a recommendation stating that the Warner Village Water District (District) has complied with all requirements necessary for the Commission to approve the District's discontinuance of water service to the four properties identified on the Town of Warner's Map 10 as Lots 3, 3-1, 6, and 7. In a secretarial letter dated September 3, 2008, the Commission, treating the District's request to discontinue service as a motion for declaratory ruling, indicated that it would approve discontinuation of service and modify the District's franchise boundaries accordingly if the customers in these four properties accepted individual wells installed by the District, which complied with RSA 485-A:29 and RSA 485-A:30-b.

Staff recommended that the Commission issue a secretarial letter approving the District's requests to: (1) discontinue water service to the foregoing lots; and (2) modify its franchise area to eliminate these lots. Staff also recommended that the Commission close the above-captioned docket after approving the District's requests.

Based on Staff's July 13, 2020 recommendation, the Commission authorizes the District to discontinue water service to the four properties identified on the Town of Warner's Map 10 as Lots 3, 3-1, 6, and 7. Further, the Commission authorizes the District to modify its existing franchise area by eliminating these four lots. This docket will now be closed.
