To the Parties:

On August 3, 2020, Commission Staff and the Office of Strategic Initiatives filed an Amended Recommendation on the use of the Clean Energy Fund. The Commission will take oral argument from the parties, as well as public comments from interested persons, concerning whether the recommended uses and allocations for the Clean Energy Fund are consistent with the principles supporting the cost effective and efficient use of these funds approved in Order No. 25,290 at 70, 91 (July 1, 2016). See also Docket No. DE 12-248, Hearing Exhibit A at EA25-EXA26.

Parties should be prepared to address whether the proposed uses and allocations meet the following four criteria provided by the 2015 Public Service Company of New Hampshire Restructuring and Rate Stabilization Agreement, June 10, 2015, at 25.

1. Support innovation in achieving clean energy benefits;
2. Leverage various sources of funds including attracting private capital to the fund and to programs supported by the fund;
3. Expand access to clean energy across customer classes in a cost-effective manner; and
4. Avoid undue administrative costs.

The hearing will be held on November 10, 2020 at 10:00 a.m.
