The increase to customers is \$30.84 per quarter resulting in a quarterly charge of \$146.68. The new rate is effective September 20, 2013. All 42 customer are effected. On December 23, 2013 the PUC issued Order No. 25,612 approving the recovery of rate case expenditures and the revenue differential between temporary and permanent rates. As a result, the Company was authorized to charge a quarterly surcharge in the amount of \$27.58 per customer over sixteen quarterly billing periods beginning with the 4th quarter of 2013.
