To the Parties:

On January 31, 2008, a duly noticed Prehearing Conference was held in the above referenced proceeding. Appearances at the Prehearing Conference were entered by representatives of Public Service Company of New Hampshire (PSNH), Bridgewater Power Company, Constellation Energy Commodities Group, Inc. and Constellation NewEnergy, Inc., TransCanada Hydro Northeast, Inc., Freedom Logistics, LLC, Halifax American Energy Company, LLC, the Office of the Consumer Advocate (participating as a full statutory party), and Commission Staff. All pending motions to intervene were granted.
