### Water Survey Results

A total of 54 residents responded (limited to one per household). Of those that responded, 3 want to go back to the old system where the water charges were included in the fixed rent amount. The majority, 50 residents, want the water to bill billed separately and for the billing system to stay the same. One resident wanted the water billed separately, but crossed out the provision that the billing system stay the same (there were no specifics offered on how the water should be billed differently).
