IOP #7 Default Letter

On 5/15/09 PSNH received a letter from FairPoint Communications dated 5/13/09 stating the following: "We received and are reviewing the March 23rd invoice for the December ice storm tree trimming. Given the magnitude of this single bill, if PSNH chooses to move forward with tree trimming plans in 2009, we will not be able to participate in any of the associated costs. This was a difficult decision for us, especially in light of the strides we have made to strengthen our working relationship. We look forward to working with you on the trimming plans for 2010."

On May 18th PSNH asked FairPoint if they would reconsider their position on maintenance trimming for the remainder of 2009 due to the recent infusion of \$50 million in capital authorized by the NHPUC. FairPoint responded that they would not be changing their position and did not plan to participate in maintenance trimming with PSNH for the remainder of 2009.

On May 20th PSNH issued a letter to FairPoint declaring them in default of IOP#7, Maintenance Trimming, and proving a written request to invoke the dispute resolution process outlined in IOP #1A, Communications, Coordination & Dispute Resolution.

On May 27th, PSNH notified FairPoint, via outside counsel, that PSNH would be attending the June 1, 2009 status conference at the NHPUC regarding Docket DT 07-011.
