On October 10, 2007 Donald Kreis, the Hearing Examiner in the above-referenced case requested that each party provide information related to witness availability, number of people attending the hearings, and time needed for cross examination. This letter provides Labor Intervenors' responses to those requests.

Labor Intervenors expect that between two and six people will attend the hearings each day. On most days, I would expect three or four people to attend.

Labor Intervenors have two expert witnesses: Randy Barber and Kenneth Peres. Mr. Barber, our financial witness, is available to testify on any day during the first week of hearings (Oct. 22 through 26). Dr. Peres, our service quality witness, is available to testify at any time. Due to the witnesses' needs to make travel arrangements and otherwise arrange their schedules, we would appreciate it if the order of witnesses and the approximate days on which the witnesses would appear could be determined as quickly as possible.

We have reviewed the proposed order of witnesses prepared by the Office of Consumer Advocate, and we concur with their proposal. The following table contains our estimated times for cross-examination, using the Office of Consumer Advocate's proposed witness order.
