Service Quality Penalties
Modification to Procedural Schedule

To the Parties:

On March 5, 2012, Northern New England Telephone Operations LLC d/b/a FairPoint Communications (FairPoint) submitted a request to reschedule the March 15, 2012 hearing established by Order No. 25,331, dated February 6, 2012. The hearing was scheduled to take evidence on FairPoint's proposal to allow it to use service quality penalties to construct and install additional broadband facilities, in lieu of customer refunds, and to consider amending provisions of Commission orders, pursuant to RSA 365:28.

According to FairPoint, it has been scheduled for some time to attend proceedings in Maine on March 15 and 16 making FairPoint personnel unavailable. Attempts to reschedule the proceedings in Maine were unsuccessful and FairPoint requested the hearing in New Hampshire be moved to March 19, 2012.

The Commission has determined that rescheduling the hearing from March 15 to March 19 will not unduly delay the proceeding. Accordingly, the hearing has been rescheduled to March 19, 2012 at 1:00 p.m.
