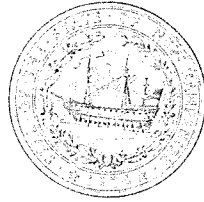

On August 7, 2013, Technology Resource Solutions, Inc. filed an application with the Commission to register as a provider of natural gas aggregation service. Staff reviewed the application and determined that it is complete.

The Commission approves your application to register as a provider of natural gas aggregation service, effective August 29, 2013. The registration is for a term of 2 years and expires at the end of business on August 28, 2015. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before June 29, 2015.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin.
