To the Parties:

On May 26, 2020, Commission Staff (Staff), in conjunction with Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty, Northern Utilities, Inc., New Hampshire Community Action Agencies, and New Hampshire Legal Assistance and The Way Home, filed a proposed procedural schedule in the above-referenced matter. Staff stated in its May 26 letter that the Office of the Consumer Advocate (OCA) would consider Staff's proposed modifications to the Residential Low Income Assistance Program (the program), but the OCA did not wish to agree to any hearing date at this time.
