Dear Ms. Howland:

By letter dated May 28, 2021, Staff of the Public Utilities Commission (Staff), the Office of the Consumer Advocate (OCA), and Liberty informed the Commission that they had reached an agreement in principle which, if approved by the Commission, would resolve all issues in this proceeding except for Liberty's request to recover costs incurred to investigate, evaluate, and assess the future development of the Granite Bridge Liquefied Natural Gas tank and related gas pipeline. In that letter, Staff, OCA, and Liberty set a target date of June 4 for filing the settlement.

Staff, OCA, and Liberty continue to work on finalizing the settlement agreement and several attachments, but now project a target date for filing of Friday, June 11. This target date is more than a week before June 21, which is the scheduled date for a hearing on the settlement.
