<u>Current Month Usage:</u> the monthly metered read calculation for period covering 4/1/20–4/30/20. Units are measured in MCF and converted to MMbtu as shown under Current Month Usage.

The Monthly Cost of Gas: the monthly usage times the commodity price, which is , as shown in Confidential Attachment Staff TS 1-1.2.

*Note: this invoice also shows the Marketer Basis Charge which was disputed by the Company at the time of payment. That charge was rejected on this invoice as it was an unresolved dispute at that time.

Service Pricing: is a fixed cost of per MMbtu as shown.

Annual Demand Fee: a fixed monthly rate of per year, which equates to

*Company has since settled the dispute with Vendor regarding the Marketer Basis Charge. Resolution included payment of back charges at per MMbtu, and forward charges reduced to per MMbtu starting in July 2020.

Pursuant to the response to Staff 1-6, Marketer basis charge of was included in that calculation. Additionally, per Staff 1-6, Liberty's Accounting department splits the demand charge by season (80% winter / 20% summer) to mitigate the cost impact of the charge in the summer months when throughput is much lower. Also noted, upon further review, some volumes in Confidential Attachment Staff 1-6.xlsx were taken from preliminary data; actual volumes have since been updated. Please see the Company's supplemental response to Staff 1-6 and Confidential Attachment Staff 1-6-REVISED.xlsx.
