

Dear Chairwoman Martin:

Enclosed please find the parties' joint exhibit list for the purpose of identifying and numbering exhibits, as required by the hybrid hearing guidelines issued in this docket. The Department of Energy (Energy) agreed, with all parties' assent, to file the joint exhibit list, which includes exhibits identified by Liberty EnergyNorth and by Energy. The Office of Consumer Advocate has not identified any exhibits.

Energy has also agreed, with all parties' assent, to file a joint witness list, enclosed herewith. The list identifies Liberty Utilities Service Corp. employees as witnesses for Liberty-Keene. Energy and the Office of the Consumer Advocate have not identified any witnesses.

The Department of Energy has includes Energy's Exhibits 7-13 herewith, except that confidential attachments shall be served to counsel under separate cover.

The Department of Energy (Energy) reserves the right to identify additional witnesses and exhibits based upon EnergyNorth's response to Energy's technical data requests, set 1. EnergyNorth's responses filed October 21, 2021.

Energy has asked Liberty EnergyNorth to mark its red-lined updated petition, including attachments and schedules, as an exhibit. As of this filing, Liberty has not confirmed that it will file a red-lined updated version for reference at hearing.

At Monday's hearing, Energy will make <u>an oral motion</u> to ask the Commission to waive the hybrid filing deadline of 4:30 pm yesterday for the joint witness list, joint exhibit list and Energy's exhibits. Liberty Energy North assents to the relief requested

(waiver). Based upon information and belief, the Office of Consumer Advocate does not believe waiver is required.

Waiver is appropriate for the following reasons: Liberty EnergyNorth's technical session data set responses were served yesterday. There was also uncertainty about Liberty-Keene filing red-lined versions of is updated filings, ostensibly replacing the original filings made on September 15, 2021. Liberty-Keene provided witness names and exhibit list at approximately 12:45 p.m. Accordingly, Energy did not have time to make the hybrid hearing guideline filings required by 4:30 p.m.

Energy asserts that waiver will serve the public interest and that it will not disrupt the orderly and efficient resolution of matters before the commission. See NH Administrative Rule Puc 201.05. Waiver serves the public interest because yesterday's 4:30 p.m. deadline is inapplicable to responses filed so close in time to that deadline. In addition, this cost of gas proceeding is an expedited matter, requiring flexibility to put relevant evidence, already somewhat familiar to the parties, before the Commission. It would be onerous to exclude relevant information, already known to all parties, from the Commission's consideration in an expedited docket of this nature. It would be unfair to prohibit Libety-Keene from introducing exhibits due to Energy's late filing.

Pursuant to the Commission's March 17, 2020 secretarial letter identifying temporary changes in Commission filing requirements due to the COVID-19 State of Emergency, the enclosed exhibit list and witness list are only being filed electronically.
