Dear Chairman Goldner:

Pursuant to the Procedural Order in the is matter dated September 9, 2022 the Department of Energy submits this letter to list the step adjustment disallowance recommendations the Department plans to make at the September 20 hearing.<sup>1</sup>

#### **Exhibits 3 and 4: Nashua Work Center Renovation**

Recommend no recovery in this step adjustment. Recommend deferral of these cost (over \$8 million) for review in the next rate case because the record does not adequately demonstrate that Eversource selected the least cost/best cost contactor for this project, and because the over budget amount of \$427 thousand was not adequately explained.

#### **Exhibit 5: Emerald Street Substation**

Recommend deferral of these cost for review in the next rate case because the project was undertaken to serve load growth and the project was over budget by over \$3 million, which has not been adequately explained.

# Exhibit 6: Pad Mount Transformer - Goffstown

Recommend disallowance of over budget amount of \$371 thousand (more than 90% over budget) due to inadequate analysis of the project at the time of decision.

### **Exhibit 7: Purchase of Transformers**

Recommend disallowance of over budget amount of \$3 million (26% over budget) which has not been adequately explained.

## **Exhibit 8: Annual Reliability Projects**

Recommend disallowance of over budget amount of \$317 thousand (9% over budget) which has not been adequately explained.

### **Exhibit 9: Maintain Voltage Project**

Recommend disallowance of over budget amount of \$428 thousand (37% over budget) which has not been adequately explained.

### **Exhibit 10: Replace Submarine Cable**

Recommend disallowance of \$15 thousand to reflect prior disallowance decision of the Commission which has not been fully reflected on Eversource's books.

### **Exhibit 11: Millyard Substation Replacement**

Recommend disallowance of \$87 thousand in real estate costs because the substation was not in service in 2021.

Consistent with the Commission's *Temporary Changes in Filing Requirements* (March 17, 2020) this letter is being filed only in electronic form.
