On August 8, 2024, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty; New Hampshire Electric Cooperative, Inc.; Public Service Company of New Hampshire d/b/a Eversource Energy; and Unutil Energy Systems, Inc.; the New Hampshire Department of Energy; the Community Action Agencies; the Office of the Consumer Advocate; and NHLA on behalf of LISTEN Community Services filed a motion with the Commission request rehearing of Order No. 27,031 issued by the New Hampshire Public Utilities Commission in the instant docket.
