Dear Chairman Goldner:

On March 17, 2023, the Public Utilities Commission (Commission) issued *Procedural Order Re: Record Requests* in the above captioned docket. In Record Request 12, included in the procedural order, the Commission requested that the Department of Energy (Department) provide, “source information, as well as the past five years of data, on competitive supplier prices for 6-month contracts.”

The Department respectfully requests that the Commission clarify the information requested. The Department maintains a comparison shopping page on the Department of Energy website. Any information the Department has on competitive supplier prices would be derived from archival files containing information originating from that webpage. The data is entered by the competitive electric suppliers and can be updated at any time. The Department understands that it can retrieve data from up to five years ago. The “source information,” would be the competitive suppliers listed.

If the Commission confirms that this is the type of data requested in the record request, the Department can attempt to filter that data by 6-month product offerings capturing the price, the renewable percentage of the product, and the timeframe that the product was offered.

The Department appreciates the Commission’s interest in competitive supplier data and makes this request in the interest of clarity and administrative efficiency. Finally, the Department would also ask that the deadline to submit said information be extended based on the date of clarification. Thank you for your attention to this matter.
