Dear Chairman Goldner,

On behalf of the Community Power Coalition of New Hampshire (CPCNH), I am requesting leave to appear at the hearing scheduled for October 1, 2024 at 9:00 a.m. in this matter.

A year ago I scheduled my annual physical with my primary care physician for 8 am on 10/1/24, near my home and office in Lebanon, NH. I've inquired as to the possibility of rescheduling this physical exam and was told last week that the next available appointment time would be April 11, 2025.
