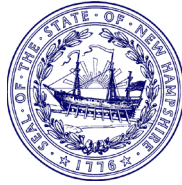



RATES:


The following Surcharge is to recover \$61,096.14, representing Step expenses, as approved by Order No. 26,963, as follows:

TERMS OF PAYMENT:

These Surcharges will be in effect for each customer as noted above for the periods noted above per customer to begin after recovery of the permanent rate case expenses previously authorized, or until the Step expenses of \$61,096.14 are collected, whichever is earlier. Bills under this rate are net and will be rendered monthly and are due and payable upon presentation. All accounts twenty-five (25) days past due will be assessed a late fee of Ten Dollars (\$10.00) at the discretion of the Company.
