
Procedural Order Re: Extension of Stay to January 21, 2025

On November 15, 2024, counsel for Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) made a filing advising the Commission that the current stay in this proceeding would expire on November 15, and requesting that the Commission extend the stay to accommodate settlement negotiations regarding this above-captioned matter between Liberty and the other parties in this proceeding.
